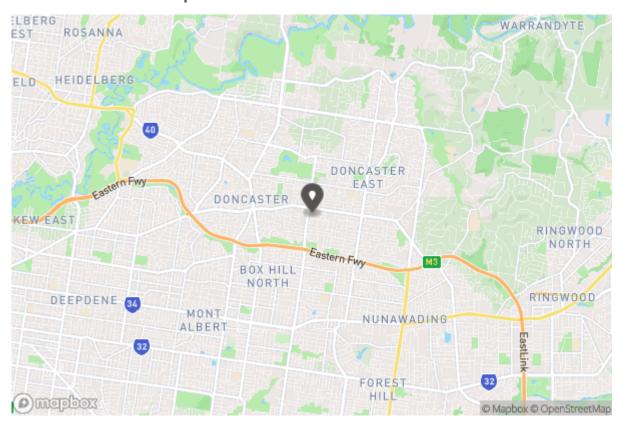






RT Edgar Boroondara 3 / 6
