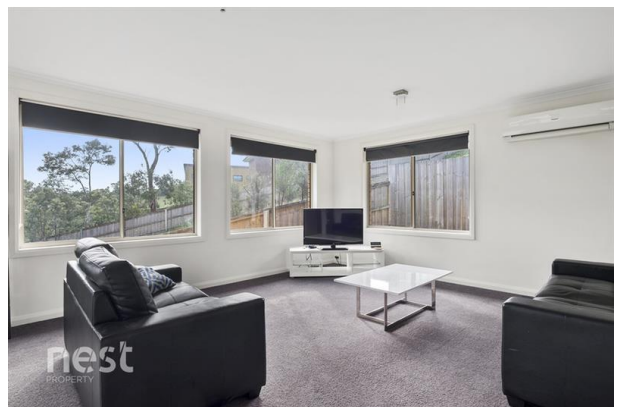
The kitchen features plenty of cupboards maximising the space available with plenty of storage and natural light. The bathroom is a good size and includes a separate shower and bath.

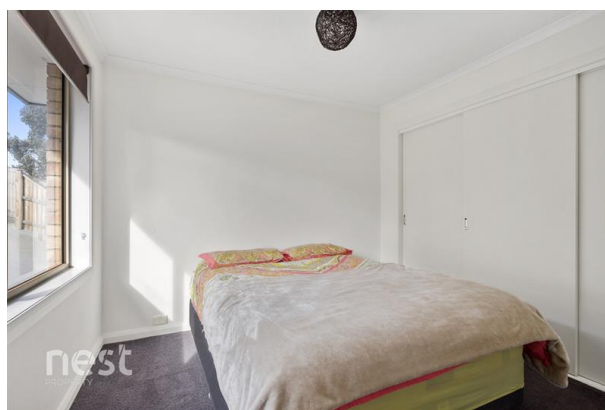
There is a full laundry with additional storage, in addition to this there is extra storage under the house. Outside the yard is easy to maintain and single car space at the door.

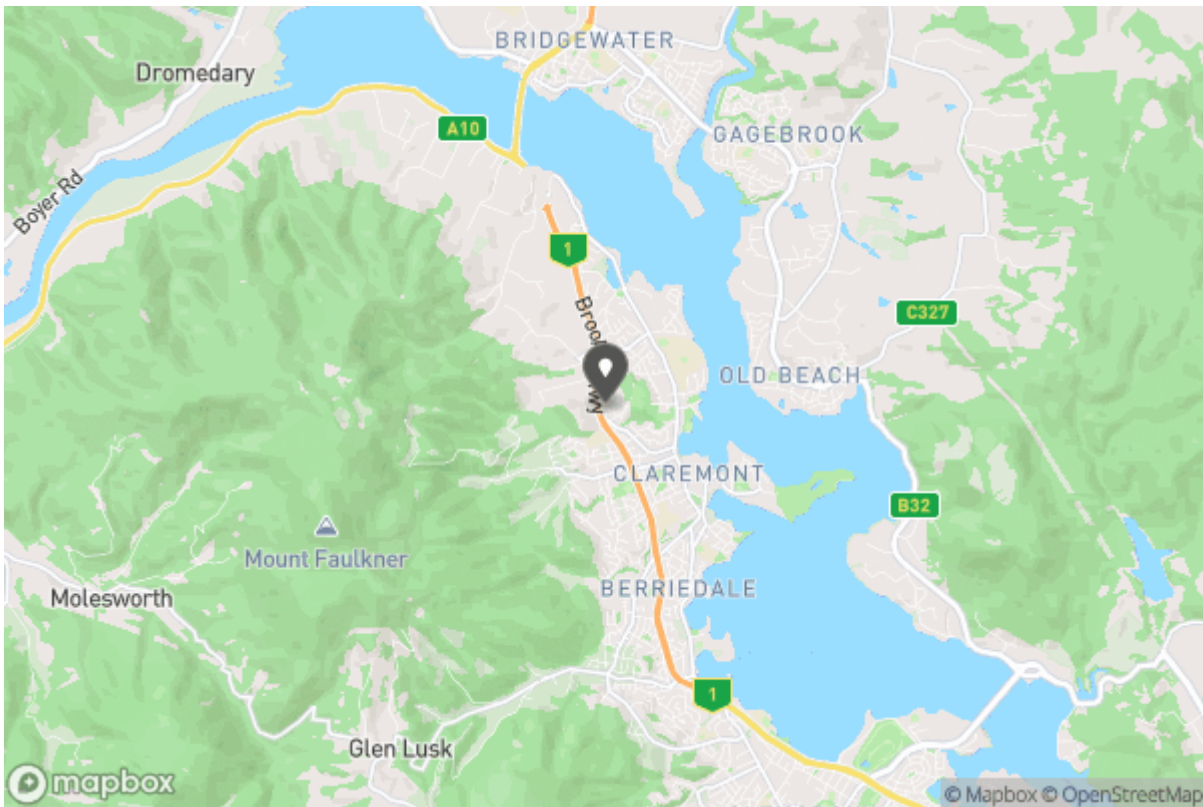
