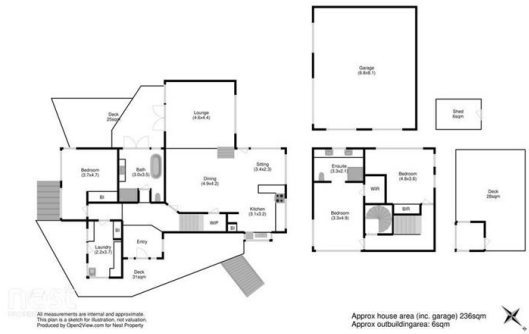

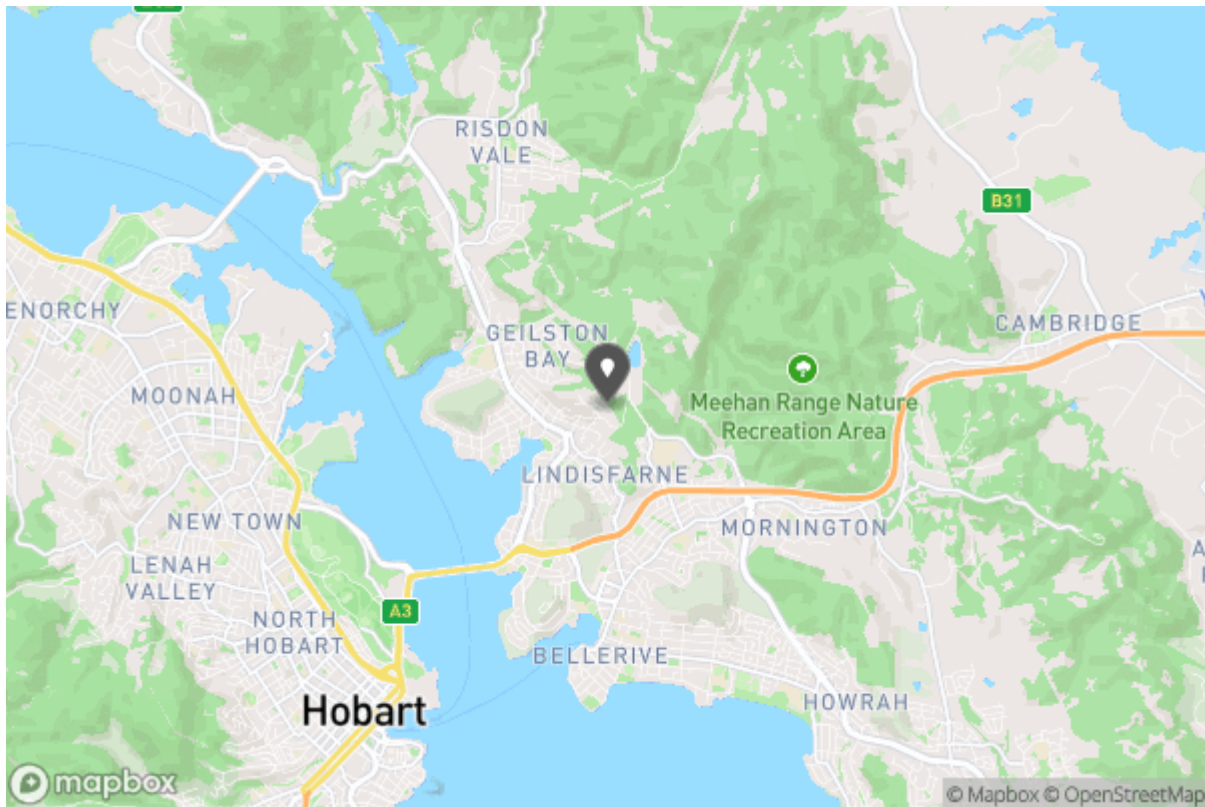

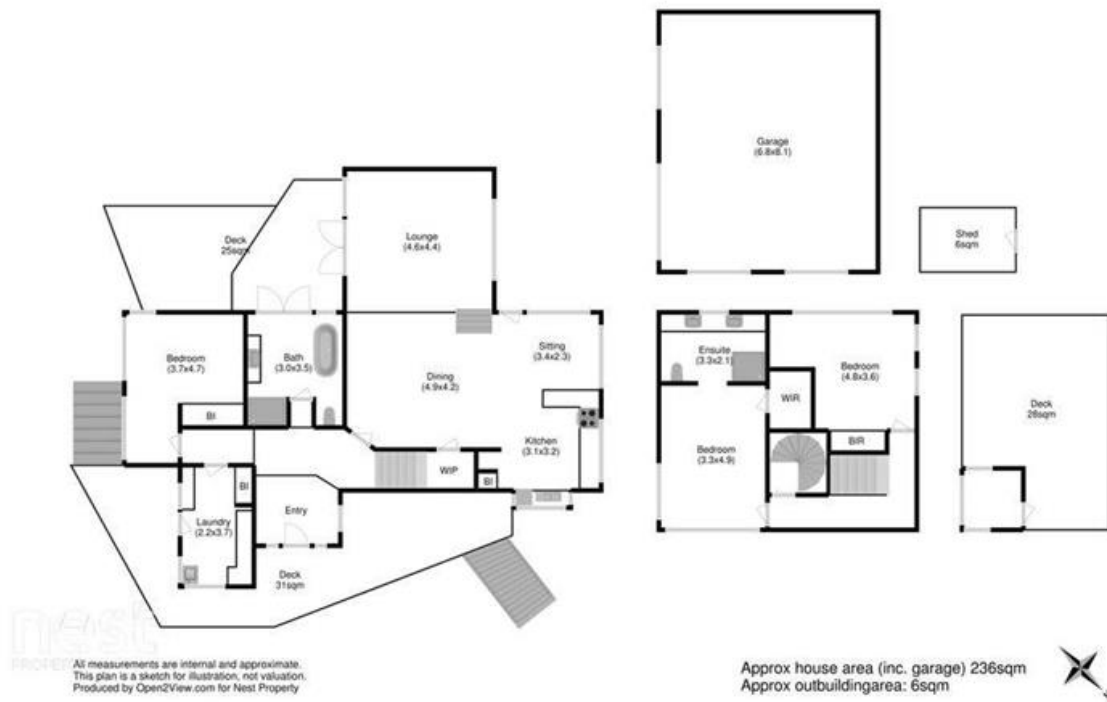




# Location Map
